



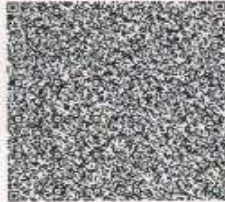

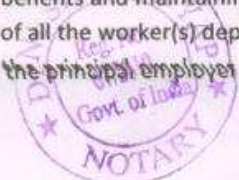

1. That I am the Director in the above company/firm and as such am well conversant with the functioning of the company depose this affidavit.
2. That the establishment of the deponent viz. **M/s Goverdhan Transport Company Ltd.** (herein after referred to as the contractor) is an independent legal identity and contractor in accordance with the provisions of the contract labour (Regulations & Abolition) Act, 1970, having its employees shall deploy **350** Nos. of employees at the premises of **M/s State Transport Authority** (herein after to as the principal Employer) to carryout Public Transport work at **Cluster VI Dilshad Garden Depot Delhi-110095**, (Address of place of work.)
3. That the deponent has entered in to an agreement with **State Transport Authority** (Principal Employer) on **Oct 2013** to carryout above work, which shall remain in force from **28 Oct 2013 to Oct 2023**.
4. The deponents have deployed the worker(s) in the premises/establishment of the principal employer doing the same nature of work which is being done by the worker(s) employed directly by the principal employer.

That the deponent undertake that each and every worker deployed by the deponent is/are being/shall be paid not less than minimum rates of wages fixed for their category of employment from time to time by the Govt. of NCT of Delhi under the provision of minimum wages Act, 1948 including overtime/weekly off etc. and it shall be paid through the account payee cheque /ECS/Bank Transfer.
6. That the establishment of the deponent is / shall be providing all statutory benefits and maintaining the records under the applicable Labour Laws in respect of all the worker(s) deployed/shall be deployed in the premises of the principal of the principal employer.
